Dear Valued Customer,

On behalf of team here at the “**Ministry of Freedom**” and myself, I’d like to personally thank you and of course, congratulate you on your purchase.

Before we get into the training and setup, I would like to kindly ask that you read and sign this document to show that you agree and abide by our terms and conditions. **This is a legally binding agreement.**

By digitally signing this document, you (Customer) agree to the following terms and conditions with no exceptions or reservations:

##### **Guarantee Terms & Conditions:**

- The Customer (you) must submit the refund request and supporting documents as required and outlined below **AFTER** the 60th Day and no later than the 70<sup>th</sup> day after the date and time of the purchase.

## B: Payment Disputes/Chargebacks

If you do decide to open a chargeback and claim “*fraudulent*” or “*not delivered*” we will provide all evidence regarding your payment/access times / screenshots / IP Addresses / uses of software / login times / Facebook Group activity, essentially everything stored on our membership systems to your credit card company/banks legal department to prove our case, you can lose access to your bank services if you do this! We do not lose these cases.

**DO NOT DO THIS!** False claiming ‘fraud’/‘fraudulent’/‘product not received’/‘not as described’ can not only damage your credit, your bank may choose to not only block your account access and services to you but also inform the authorities as fraud is a crime and will be treated as such.

## C: Rebill Payments (Split Payment Buyers Only)
